What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  Social Security Number and Income  Account Balances and Payment History  Credit History and Credit Scores	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons GenoaBank chooses to share; and whether you can limit this sharing.

These measures include computer safeguards and secured files and buildings.  We only authorize our personnel to access information about you when they need it to do their work.  We require companies working for us to protect your information.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.			
<b>Definitions</b>				
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  GenoaBank shares with its affiliate, GenoaFinancial.			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  GenoaBank does not share with nonaffiliates so they can market to you.			
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  GenoaBank does not jointly market.
